FROM THE PRESIDENT

It is hard to believe that we are approaching the end of 2023! This month we are excited to launch a special fundraising campaign in honor of ICGFM's 45th Anniversary. For more than four decades, ICGFM has been the premier global resource advancing the dynamic profession of public financial management to create value for citizens and protect the public interest. As we celebrate this milestone year, we need your help to continue to promote best practices in public financial management globally through advocacy, education, and awareness.

ICGFM was officially incorporated in late October 1978 in Washington, DC. There were three original officers of the organization. I thought I would share a bit about our three original officers.

Mortimer Dittenhofer was a Ph.D, a Certified Internal Auditor, a Colonel in the US Army who landed at Omaha Beach with a pistol, carbine and adding machine, a government supergrade, and an extensively published author. He worked for the Atomic Energy Commission, NASA, HEW, GAO and there developed "The Yellow Book" which established the audit standards practiced by government all over the world and has been translated into 23 languages. He transitioned to teaching at DePaul university, Idaho State and Idaho University, The George Washington University and American University. He became an associate professor of accounting and auditing at Georgetown University for seven years and at Florida International University for 16 years. He retired at 88 and continued publishing until he was 100. He died at 102 in 2016.

Donald W. Beatty served for 12 years as the Executive Director of the Government Finance Officers Association and then worked for Northern Trust Bank for their Government Public Funds department and later for Irving Trust. He passed away in 2009.

James P. Wesberry, Jr. served four years as Director of USAID's Hemisphere-wide Americas Accountability/Anti-Corruption Project, then led similar projects in Mexico, Ecuador and the Philippines. He served four years as Senior Accounting and Auditing Advisor for Latin America and the Caribbean at the World Bank and a similar four-year position Senior Financial Advisor for the LAC Region at USAID. Previously, he was Director of International Operations, Americas Region, Price Waterhouse. Auditor General of the Organization of American States, Consultant to the Comptroller General of Peru, Ecuador, Bolivia and the United States and the Latin American Auditing Institute, President of the Institute of Public Administration of New York, as well as several corporate positions.

As I noted last month, ICGFM's importance over the next 45 years may be even more critical than the last 45 years. The world economy has become increasingly complex, while at the same time trust in government institutions has declined. As a membership association, ICGFM's strength and relevance comes from our members. The more members we have and the greater diversity of members with knowledge and a passion for improving PFM, the stronger we will be.

This is an historic anniversary for ICGFM. Please join the celebration and make your contribution today.

Worldwide Search Launches for Volunteer Members to Serve on the IPSASB

A worldwide search has launched [for volunteers to serve as members](#) on the International Public Sector Accounting Standards Board (IPSASB), an independent standard-setting body that serves the public interest by setting high-quality standards for use by public sector entities globally in the preparation of general purpose financial reports.

The initial-term of service for these volunteers will span three years, commencing on January 1, 2025. Candidates will ideally have a public sector background, with experience in standard setting and/or sustainability reporting. Out for comment now, the IPSASB's draft Strategy and Work Program 2024-2028 proposes a shift from developing new standards towards maintaining the IPSAS suite of standards and embeds the Board's work in public sector sustainability reporting. Volunteers who can contribute to the changing scope and focus of the Board's work are especially sought. English proficiency (both written and oral) is essential, as this is the language in which the IPSASB operates, although nominations from jurisdictions where English is not the predominant language, are encouraged.

The International Federation of Accountants (IFAC) today announced that Lee White has been named to succeed Kevin Dancy as CEO. Mr. White will assume his new post in March 2024 and will be based in London.

Mr. White, who has been with the IFRS Foundation since 2018, has more than 30 years of global executive, regulatory and leadership experience. A chartered accountant, Mr. White has most recently led the creation of the International Sustainability Standards Board (ISSB) within the IFRS Foundation and the launch of the ISSB's first two standards in June. Mr. White is an avid champion of the role of professional accountants in driving and delivering high-quality sustainability-related disclosure and assurance.

IPSASB Issues IPSAS 49, Retirement Benefit Plans

The International Public Sector Accounting Standards Board® (IPSASB®), developer of international accrual-based accounting standards for use by governments and other public sector entities around the world, has issued [International Public Sector Accounting Standard® \(IPSAS®\) 49, Retirement Benefit Plans](#).

IPSAS 49 establishes comprehensive accounting and reporting requirements for the financial statements of retirement benefit plans, with participants comprising current and former public sector employees and other eligible members. The new pronouncement will bring increased transparency and accountability to these public sector entities, ensuring they can fulfill their obligations to employees and other eligible participants who are members of the retirement benefit plan.
